Mission Statement

Helping Foster Youth Transition to Independence - The mission of Fostering Goodwill is to act as a resource for aging out youth (ages 17-26) in Kentucky foster care and assist this population as they transition away from the state's care and become independent members of society. This includes educating the youth about their rights, informing them about available resources within the community and assisting them in completing tasks necessary to be on their own. This includes helping them secure basic needs such as food, housing, transportation, employment, education, etc.

Background Statement

Fostering Goodwill was founded in 2006 by friends and co-workers Earl Washington, of Lexington, and Jeff Culver, of Louisville, in an effort to assist teens transitioning from foster care to adulthood. These youth age out of Kentucky's child welfare system with no parental or family support causing many to be angry, alone and uncertain about their futures. Earl, a social worker and former foster youth, and Jeff, a social worker, decided to address this need and work with older teens in the child welfare system to encourage them as they worked to live independently for the first time in their lives. Partnering with F.O.C.U.S., a basketball academy in Louisville that teaches life skills through basketball, an outreach in Lexington called Fostering Goodwill was created to work with teens to connect them with local resources and motivate them to work toward achieving their full potential. In December 2006, with support from the Lexington business community, Fostering Goodwill provided 100 teens with \$20 gifts cards in what was the first Christmas Wishes event. This event has grown over the years and has been hosted at Gattitown over the past several years. Youth and their children attend for a night filled with friends, food and gifts with over \$10,000 in gifts distributed.

Eventually due to job relocation, Earl and Jeff were both in Lexington and the decision was made to have Fostering Goodwill located under a Lexington based non-profit. For several years, the organization was affiliated with Kentucky United Methodist Homes for Children and Youth where Earl is currently employed. In 2012, a move was made to Speigle Hill Community Center, Inc. as Fostering Goodwill was able to partner with their parent church, Antioch Missionary Baptist Church, for monthly meeting space for the Fostering Goodwill Board and quarterly youth meetings for the youth served. Finally, in May of 2015, Fostering Goodwill obtained its own 501(c)(3). The organization is totally volunteer driven by a small board of directors along with Earl, Jeff and Chorya Morton. Donations from individuals and businesses provide our funding, and we received our first grant in the amount of \$1,500 in 2015 to assist with our Quarterly Youth Meetings. Our annual events for the youth are Christmas Wishes and a Graduation Celebration. Fostering Goodwill also hosts Quarterly Youth Meetings providing food and a life skills speaker for the youth. We offer the Second Chance Scholarship for youth who were not successful the first time they attempted college but show a commitment and determination to try again. Over the years, we also have given out gift cards and bus passes regularly to former youth that have contacted us and are in need of food and transportation. Future plans include rolling out a mentoring program in 2017, holding our 3rd Race for Independence 5K, establishing an endowment for the scholarship and growing the expertise of our board.

CEO/Executive Director Statement

Every year in our country there are thousands of adolescents who age out of the child welfare system. Many of these youth age out with no parental or family support. Some of these adolescents have become dependent on the child welfare system for survival as they have spent most of their lives relying on the resources of the system. According to research, this population is among societies most vulnerable in regards to becoming incarcerated, homeless, pregnant, and developing substance abuse issues.

I am very familiar with the above mentioned facts as I spent almost ten years of my life residing in out of home care through Kentucky's child welfare system. I grew up in a low income, inner city neighborhood in Lexington and had life experiences that sometimes made it difficult for me to realize my full potential. Over the course of my time in the state's care, I experienced first hand the many obstacles that foster youth have to overcome. My personal background partially assisted me in developing the work ethic and confidence that it took for me to be successful to this point in my life. However, my interactions with people within the child welfare system as well as people within the community helped me see a vivid picture of my full potential. It was truly a calling for me to give back to the community and help kids who are in the foster care system. I fully believe in the adage "without struggle there is no progress." I am dedicated to helping individuals, groups, and communities realize their full potential. I believe that through my commitment to social justice and advocacy I will continue to live out all the potential possibilities.

Fostering Goodwill is a Lexington, Kentucky based 501(c)(3) organization that assists older youth in the child welfare system to enhance their potential of self determination. This organization has pledged its commitment to fostering a sense of empowerment to motivated individuals in the foster care system within our community. These adolescents need specific resources that can increase the chances they become independent and productive members of society. Unfortunately, some of these resources are not provided to them. Our organization challenges individuals and businesses to help these foster youth reach their full potential and in turn help our community reach its full potential as well.
